CANCELLATION POLICY

The following policy applies to refunds of registration fees:

- ♦ Cancellation on/or before **March 31, 2023**: Refund = full amount of registration fees and event tickets less a \$65 cancellation fee.
- ♦ Cancellation between **April 1 and May 26, 2023**: Refund = 50% of registration fees and event tickets.
